PREREQUISITES

Certification shall be valid for life without retesting after two (2) recertifications by examination. Lifetime certification requires reregistration every five (5) years with evidence of continuing experience, education or training and valid ACI Concrete Field Testing Technician Grade I certification. Failure to reregister within 90 days of the expiration date shall require reexamination to reinstate lifetime certification.

Continuing experience, education or training must include at least one of the following:

- pass the Level I examination;
- attend a Level I school (without taking the examination);
- submit evidence of 15 hours of continuing education or training in the field of quality control, concrete, or other topics related to the industry;
- submit evidence of 36 months of continuing work experience during the past five years, in the field of quality control, engineering, or production in the precast concrete industry.
