He will also administer the architectural project survey and site evaluation systems for the plant certification program as these are implemented over the coming months.

PCI Production Workshop returns in October

The Architectural Precast Committee will be conducting an in-person workshop that will include a full day of experienced speakers along with a day of plant visits and demonstrations October 18–20, 2022, in Milwaukee, Wis.

This year, the Production Workshop will focus on the various types of forms—wood, steel, 3-D, computer numerical control, foam, liners, thin brick, terra-cotta, and more—and techniques to produce high-quality architectural precast concrete. The speakers will be a combination of precast concrete producers and PCI associate members.

Attendees will visit AA-certified plant International Concrete Products (ICP) in Germantown, Wis., where the ICP team and associate members will provide demonstrations during the tour.

This exclusive workshop is designed for plant foremen, carpenters, quality control technicians, and other key architectural precast concrete producer personnel and is limited to 80 precast concrete producer members.



PCI committee publishes new UHPC guidelines

PCI recently released *Guidelines for the Use of Ultra-High-Performance Concrete (UHPC) in Precast and Prestressed Concrete*, TR-9-22. This publication from the PCI Concrete Materials Technology Committee provides a practical guide for the development and qualification of UHPC mixtures based on locally available materials. UHPC is a high-strength, high-durability composite material consisting of a cementitious matrix with high-performance-fiber reinforcement.

TR-9-22 presents an overview of UHPC production specific to long-span precast, pretensioned UHPC structural elements for buildings and bridges. Many of the practices discussed apply to the production of a variety of UHPC elements. Topics include constituent materials and the development of mixture proportions, batching and placement considerations for production, and methods for evaluating UHPC materials for mixture qualification and routine quality assurance.

COOPERATION SPURS INNOVATION



I have really enjoyed becoming more familiar with the innovative programs at the universities and have been heartened by the tremendous enthusiasm I've seen from all those involved. The professors' efforts and energies have done so much to further the objectives of the PCI Foundation, it makes it truly exciting to think of what comes next. As the PCI Foundation studio program has developed over the past few years, we are finding that each school takes a unique approach to working with its students. That means that as an industry, we have a number of new ways to interact with the schools, the professors, and the students, not only in teaching precast concrete, but also in reshaping how research opportunities are envisioned and pursued.

For the past several years, PCI has tried to broaden its research scope to include other areas of interest and impact beyond what might otherwise be covered by civil and structural engineering. There is now an operations category within the research needs list, and we have an Innovation Committee under the Research and Development Council, with several professors as members, including Carlos Barrios from Clemson University. The main task of that committee is to come up with outside-the-box thinking to spur us on to delve into things we hadn't previously considered.

The committee has encouraged several successful fellowship applications, including safety training using virtual reality from Mississippi State University and scanning methods to enable real-time quality control of fabricated product with greater accuracy from Virginia Tech.

With what I've seen in several of the studios, collaboration between university departments is alive and well and quite possibly just what we need to take our fellowships to another level. Within our studio programs, we are seeing inter-departmental cooperation among architecture, engineering, and construction management programs. This opens up new relationships between professors who previously did not have reason to work together and creates new opportunities for cooperative research projects that could well align with the schools' and PCI's goals. Challenging our project approach with a proof-of-concept aspect supported across multiple disciplines carries intriguing possibilities as to what we might come up with. Topics having to do with building envelopes, modularization, and robotic assembly-line-producible product are just a few ideas to get the conversation started, and I look forward to starting that discussion within both PCI and the PCI Foundation.

Cooperation is key, and we look forward to welcoming more of the PCI Foundation studio professors to PCI committees to help us kick into high gear.
