

2025 APC PRODUCTION WORKSHOP WAIVER OF LIABILITY AND HOLD HARMLESS AGREEMENT

- 1. In consideration for receiving permission to participate in PCI's APC Production Workshop described above ("Workshop"), I hereby release, waive, discharge, and covenant not to sue the Precast/Prestressed Concrete Institute, its officers, agents, or employees (hereinafter "PCI") and the owners of the above referenced Tour Locations (collectively, PCI and the owners of the Workshop locations (hereinafter the "Released Parties") from any and all liability, claims, demands, actions, and causes of action arising out of or related to any loss, damage, or injury, including death, that may be sustained by me or any property belonging to me, while participating in the Workshop and while in, on, or upon any premises where the Workshop is being conducted, regardless of whether such loss is caused by the negligence of Released Parties or otherwise, and regardless of whether such liability arises in tort, contract, strict liability, or otherwise, to the fullest extent allowed by law.
- 2. I am fully aware of the risks and hazards connected with road transportation, touring industrial facilities, and the other activities involved with the Workshop, and that such risks and hazards include injury and even death. With this understanding, I hereby elect to voluntarily participate in these activities, knowing that they may place my person and my property at risk. I understand that neither PCI nor the other Released Parties require me to participate in this activity. I voluntarily assume full responsibility for any risks of loss, property damage, or personal injury, including death, that I may sustain, or any loss or damage to my property as a result of being engaged in such activities, whether caused by the negligence of the Released Parties or otherwise, to the fullest extent allowed by law.
- 3. I further hereby agree to indemnify and hold the Released Parties harmless from any loss, liability, damage, or costs, including court costs and attorney fees that I may incur due to my participation in said activities, whether caused by negligence of the Released Parties or otherwise, to the fullest extent allowed by law.
- 4. It is my express intent that this Agreement shall bind the members of my family and spouse, if I am alive, and my heirs, assigns and personal representative, if I am deceased, and shall be deemed as a release, waiver, discharge, and covenant not to sue the Released Parties. I hereby further agree that this Agreement shall be construed in accordance with the laws of the State of Illinois and that any lawsuit relating to the Workshop must be filed only in the State of Illinois or the federal or state courts located in Chicago, Illinois. Any portion of this document deemed unlawful or unenforceable is severable and shall be stricken without any effect on the enforceability of the remaining provisions.
- 5. I acknowledge and represent that:
 - · I have read and understand this Waiver of Liability and Hold Harmless Agreement;
 - Apart from this Agreement, no representations, statements, or inducements regarding the Workshop have been made to me;
 - I am at least eighteen (18) years of age and fully competent to participate in the Workshop; and
 - I have personal health insurance.
